# Request for an Adjudication Certificate Guidance Notes

## Section 1

1. The request must be lodged with the Authorised Nominating Authority (ANA) which nominated the Adjudicator.
2. The request cannot be made before the expiration of either 5 business days after the Adjudicator's Determination was served on the Respondent or immediately after a later date (determined by the Adjudicator) as the date on which the progress payment became payable.
3. The request cannot be made unless the whole or part of the Adjudicated Amount remains unpaid at the date of the request.
4. The request must be accompanied by the fee charged by the ANA for issue of the Adjudication Certificate.

## Section 2

1. Interest **will not** be included in the Adjudication Certificate unless the Claimant completes Section 2.
2. Interest must be calculated at the rate determined by the Adjudicator in the Adjudication Determination. Interest is simple interest unless the Adjudicator has determined otherwise.
3. In calculating interest, the date upon which the progress payment became payable (as determined by the Adjudicator) should not be included but the date of this application should be included.
4. In respect of the amount determined by the Adjudicator, interest should be calculated only on unpaid amounts as at the date of the Request for an Adjudication Certificate.
5. The interest rate determined by the Adjudicator **does not** apply to adjudication fees.
6. Any interest calculation which covers two or more periods, must be shown as a separate interest calculation.
7. The formula which may be used to calculate simple interest payable is as follows:

### Formula

Adjudicated Amount (incl any GST)	x	Number of days since due date for payment	÷	365*	x	Rate of Interest	=	Interest Due

### Rate Prescribed under the Supreme Court Act 1935

The *Supreme Court Act 1935* at section 114 states "All money, including costs, payable under any judgment or order shall bear interest at the rate from time to time prescribed by the rules of court".

### **Rules of the court from 1 July 2010 to 17 May 2020\***

Rule 217 of the *Supreme Court Civil Supplementary Rules 2014* reads as follows:

"(i) in respect of the period from 1 January to 30 June or part of that period in a year, the cash rate of interest last set by the Reserve Bank of Australia before that 1 January, plus 6 percent per annum; and

(ii) in respect of the period from 1 July to 31 December or part of that period in a year, the cash rate of interest last set by the Reserve Bank of Australia before that 1 July, plus 6 percent per annum."

Therefore, the rate prescribed under the *Supreme Court Act 1935* during this period varies as the cash rate changes. The Claimant may consider reviewing the Reserve Bank of Australia website at <https://www.rba.gov.au/> to satisfy itself of the relevant rate of interest.

**Rules of the court from 18 May 2020 to date\***

The *Uniform Civil Rules 2020* at Section 185.1(1) reads as follows:

- (1) *Subject to subrule (2), interest on a judgment accrues on and after the commencement date at the rate of 6 per cent per annum.*
- (2) *The Chief Judicial Officer may from time to time prescribe another rate of interest in respect of a period from not earlier than the first anniversary of the commencement date onwards.*
- (3) *The Registrar must publish all adjustments made under subrule (2) on the CAA website.*

The following table provides what Adjudicate Today understands is the relevant interest rate under the *Supreme Court Act 1935* for certain periods:

<b>PERIOD</b>	<b>INTEREST RATE (%)*</b>
1/07/19 to 31/12/19♦	7.25
1/01/20 to 17/05/20♦	6.75
18/08/20 to date**	6.00

**\* In all cases, the Claimant MUST make its own enquiries to satisfy itself of the relevant rate of interest.**

**Section 3**

1. If the Claimant has paid the Respondent's share (or part of the Respondent's share) of the fees of the Authorised Nominating Authority and/or the Adjudicator, the Claimant should complete Section 3.
2. Adjudication fees **will not** be included in the Adjudication Certificate unless the Claimant completes Section 3.

**Declaration**

2. If the Claimant is a company then an officer duly authorised by the company should complete the Application Form.
